IMPORTANT NOTICE

Leisureland Pty Ltd (Jungle Float) is the supplier of recreational services on the Jungle Float and is subject to the Australian Consumer Law. All recreational services (including all sporting or leisure activities of any kind) provided by Jungle Float on and related to the Jungle Float are subject to the Conditions of Entry below.

WARNING: The recreational activities (including all sporting or leisure activities of any kind) provided by Jungle Float on and related to the Jungle Float carry inherent risks which can result in serious personal injury and/or death. Particular injuries include twists, sprains, broken bones, spinal injury, paralysis, physical injury and/or death. Accordingly, it is important to understand the Conditions of Entry and comply with instructions provided by or on behalf of Jungle Float.

CONDITIONS OF ENTRY

The Conditions of Entry apply to all persons who use the Jungle Float.

1. By participating in the recreational activities, you accept the inherent risk associated with those activities on and related to the Jungle Float. As such, you agree to:
 - a. Release Jungle Float and all persons or corporations associated with or related to the conduct of all recreational activities on and related to the Jungle Float from all claims, demands and proceedings arising out of your participation; and
 - b. Indemnify and hold harmless Jungle Float (and all associated or related people or corporations) against all liability (including liability for their negligence and the negligence of others), damage and expense associated with all injury, loss or damage arising out of or related to your participation in the recreational activities.
2. Children under the age of 13 years are not permitted to engage in the recreational activities on and related to the Jungle Float unless under the direct supervision of a parent or guardian at all times. Where you are responsible for the supervision of any children in your care, you agree to be bound by these conditions of entry on their behalf.
3. Children between the ages of 13-18 years are not permitted to engage in the recreational activities on and related to the Jungle Float without the consent of a parent or guardian.
4. You may not:
 - a. Bring glassware, food (including commercially prepared food), beverages, eskies or coolers to the Jungle Float;
 - b. Before, or during the recreational activities on and related to the Jungle Float consume alcohol or chew chewing gum; or
 - c. Smoke on the Jungle Float.
5. Photographs, movies or videos taken by you must be for your own personal use and enjoyment and not for any commercial purpose.
6. For safety reasons:
 - a. The maximum weight limit for an individual is 110kg.
 - b. Mobile phones and other electronic devices must not be used during recreational activities on and related to the Jungle Float.
7. You may be removed from the Jungle Float for inappropriate behaviour. You may be refused entry or removed from the Jungle Float if you are under the influence of drugs or alcohol.
8. You must comply with all signs on the Jungle Float and any verbal directions issued by Jungle Float staff.
9. You consent (and consent on behalf of any child under your supervision or for whom you have granted consent) to receiving any medical treatment that Jungle Float staff consider reasonably necessary during or after engagement in the recreational activities on and related to the Jungle Float and you agree to reimburse Jungle Float for any associated costs.
10. You are responsible for all your personal property on the Jungle Float at all times.
